I would like to refer to the following mandatory requirement pat 6.2 stated in the RFQ, the requirement of a "BEE consulting services certificate", SANAS does not accredited consultants but rather verification agencies. Furthermore, verification agencies are not allowed to consult for clients whom they will in turn be verifying.

The only certificates that SANAS issues is for a verification agency.

Please clarify that this requirement was written in error.

# ANSWER: Please note, the RFQ has been updated to exclude the required of SANAS accreditation.

**BEE Consultancy Services Certificate:** SANAS Valid Accreditation certificate to provide B-BBEE Consultancy (Proof of certificate to be submitted).

Currently there are no BEE Consultancy Services Certificate accredited by SANAS. Only verification Agencies. We therefore humbly request INSETA to relook at this requirement as BEE Consultants are not regulated.
