6. Question:

At the briefing session held on Friday 10 September 2021, it was confirmed that INSETA requires a ceiling price for the internal audit services for a period of 3 years and 10 months.

However, there was no indication on the RFP documents or during the briefing session as to the number of hours required to calculate a ceiling price, whether it is annual or over the full engagement term. It was also unclear as to how the work for the 10 months should be scheduled, i.e., full plan but to be completed over 10 months, or a pro-rata for 10 months of a full annual plan?

Could INSETA clarify the above so that proposals may be completed in line with the RFP requirements?
