1. PREAMBLE

- INSETA is a schedule 3A Public Entity in terms of the PFMA. INSETA must perform in accordance with the Skills Development Act (SDA), the Skills Development Levies Act (SDLA), the Public Finance Management Act (PFMA), any other relevant legislation and the INSETA constitution. (Read more on www.inseta.org.za).

2. BACKGROUND AND PROJECT OBJECTIVES

2.1. Background

- The Insurance Sector Education and Training Authority hereby invites experienced and suitable service providers to submit quotations for supply and delivery of flowers (floral arrangement) to INSETA offices on weekly basis for the period of two (2) years or 24 Months starting from 1 April 2020 to 31 March 2022.

2.2. Scope of work:

- The service provider will be required to supply and deliver four (4) sets of durable floral arrangements (mixed bunch) for reception areas and executive management offices. The fresh flowers will be delivered once a week (Monday Mornings) the quality of flowers must be able to last for a minimum of 10 days in the water glass vase.

- The service provider will also be required to provide INSETA with fresh flowers on an ad-hoc basis or as and when required based on INSETA request.
- Flowers must be able to last for at least for 10 days.

- The service provider must have a minimum of three (3) years' experience in preparing and supplying floral arrangements. Bidders shall submit company profile demonstrating minimum of three (3) years
- Submit minimum of two (2) reference letter(s) for current or previously service rendered from Clients which must be in the Client's letter head, signed by relevant Client's authorized representative and be relevant to the service required by INSETA. Reference letters will be verified by INSETA.

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
