SECTION A: BURSARIES FOR YOUTH

INSETA hereby invites all Public Higher Education Institutions in the Insurance and related services sector registered with INSETA, to apply for bursary for unemployed youth programme for the 2023 academic year.



IMPORTANT TO NOTE:

1. Only Public Universities, University of Technology (UOT's) and TVET Colleges, are eligible to apply (No applications directly from learners to INSETA will be considered).
2. TVET College, Public Universities and University of Technology (UOT's) will be approved only subject to their compliance with the criteria set and the availability of funds as INSETA would like to reach all provinces with the funded projects.
3. No Public Institution will be considered for funding outside the funding process.

APPLICATION

1. **Number of unemployed learners granted Bursaries (new enrollment):** students funded by INSETA for the first time, regardless of the level of study or academic year.
2. **Number of unemployed learners granted Bursaries (Continuing):** students funded by INSETA from 2022 academic year to continue with their studies in the 2023.
3. **Number of unemployed learners granted Bursaries (completions):** students who are in the final year of obtaining a full qualification and legible for graduation.

SECTION B: BURSARY FOR WORKERS (CONTINUING STUDIES)

INSETA hereby notifies all levy paying and non-levy paying employers who have students (beneficiaries) who were previously funded by INSETA under Bursary for Workers Program to send an Expression of Interest applying for continuation of studies funding OR studying a qualification that has more than one year.



IMPORTANT TO NOTE:

1. Employer must have submitted their WSP/ATR for the 2021/2022 period.
2. The qualification must be SAQA registered, credit bearing and NQF aligned.
3. The window seeks to provide an opportunity to employers to apply for learners who were beneficiaries of the bursary for workers programme in the 2021/2022 financial year but have not been approved on the 2022/2023 Discretionary Grants Window that closed in April 2022.
4. Employers can also apply for learners who were previously funded OR studying a qualification that has more than one year but were not included in the Discretionary Grant Application Window that closed in April 2022.
5. The window is for continuation of studies therefore the learners must enrol for the same course they were funded for previously.

The applications will only be approved subject to compliance with the criteria set and the availability of funds. The application form must be completed in full for consideration and further evaluation.

SECTION C: SKILLS PROGRAMME FOR WORKERS

INSETA hereby notifies all levy paying and non-levy paying employers to submit an Expression of Interest to apply for Skills Programme funding for employees that are required to have completed **Class of Business** OR **Regulatory Exam** by no later than 31 March 2023



IMPORTANT TO NOTE:

1. Employer must have submitted their WSP/ATR for the 2021/2022 financial year.
2. INSETA will only fund for the preparation of the Regulatory Exam and not the Exam Fee.

The applications will only be approved subject to compliance with the criteria set and the availability of funds. The application form must be completed in full for consideration and further evaluation.
