2. SDP must recruit 20 Lecturers from Gauteng TVET Colleges to participate in the Programme.
3. The SDP must confirm three Industry Experts to Present in the Insurance Capacitation Day.
4. The SDP is required to Book a Training Venue that will accommodate and cater for the Beneficiaries. **(Venue must be in the Johannesburg)**
5. No other SDP applications for services will be considered for funding outside this process.
