THE LEARNER MATERIALS COMPRISE OF LEARNER GUIDES, WORKBOOKS, WORKPLACE LOGBOOKS, ASSESSMENT INSTRUMENTS, RPL GUIDELINES AND OTHER SUPPLEMENTARY AND SUPPORTING RESOURCES.

### 1. DELIVERABLES

The development of learner materials for listed occupational qualifications. The learning materials must comprise of learner guides, workbooks, workplace logbooks, assessment instruments, RPL guidelines and other supplementary and supporting resources for specific occupational qualifications.

- **2.2.3.** Supply any supplementary materials and resources that would ensure learner progression to the next level qualification study;
- **2.2.4.** Develop learner evidence collection tools/templates i.e., workplace logbooks and guidelines as guided by the QCTO occupational qualification curriculum.
