1. BACKGROUND

- 1.1 The Insurance Sector Education and Training Authority (INSETA) is a public entity listed in Schedule 3A of the PFMA and was established in March 2000. The INSETA must, in accordance with any prescribed requirements perform in accordance with the Skills Development Act (SDA), the Skills Development Levies Act (SDLA), the Public Finance Management Act (PFMA), any other relevant legislation, and the Constitution.
- **1.2** The objective of this request is to appoint a competent service provider to supply and deliver Laptop Charges to INSETA.

2. PURPOSE

2.1 This RFQ aims to invite a qualified and experienced service provider to supply and deliver the Laptop Charges to INSETA.

3. SCOPE OF WORK

6. TIMELINES AND DELIVERY

6.1 The successful service provider must deliver Laptop Charges by no later than 10 JULY 2023.

7. CONTRACTUAL OBLIGATION

- 7.1 In the case of the service provider using sub-contractors, the former will be responsible for ensuring the delivery of services from any such sub-contractors and for making any payments tosuch sub-contractors.
- 7.2 Bidder will be subjected to an annual review in terms of measuring satisfactory performance.
- 7.3 The successful bidder will be required to have adequate professional indemnity as well asliability insurance in place (upon parties contracting)
- **7.4** Bidders are required to fully comply with the relevant SCM Legislative Framework and apply regulatory and prescripts. Bidders are also required to take all reasonable steps to protect the information, in line with the provisions of the POPIA 4 of 2014.

8. ABSENCE OF OBLIGATION & CONFIDENTIALITY

- **8.1** No legal or other obligation shall arise between the service provider and INSETA unless/untilboth parties have signed a formal contract or Service Level Agreement in place.
- 8.2 The Contract site is at INSETA (as and when required).

9. WORKMEN AND SUPERVISION ON SITE

9.1 The service provider shall be held responsible for the conduct of his employees and the conduct of his sub-contractor employees for the full duration of the contract.

10. PREFERENCE EVALUATION

10.1 Specific Goals and Price

As the tender **price is estimated to be between R2001 and R50 million including VAT**, the tender responseswill be evaluated on the **80/20**-point system.

11. ADJUDICATION USING A POINT SYSTEM

- **11.1** The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder.
- **11.2** Preference points shall be calculated after the process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 11.3 In the event that two or more bids have scored equal points in terms of price and preference points for BBBEE, the successful bid must be the one scoring the highest number of preference points for BBBEE in terms of PPPFA Act 5 of 2000.
- 11.4 However, when functionality is part of the evaluation process and two or more bids have scored equal points for BBBEE, the successful bid must be the one scoring the highest score for functionality.
- **11.5** Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

12. POINTS AWARDED FOR PRICE AND BBBEE PREFERENCE POINT

The 80/20 preference point system.

A maximum of **80** points is allocated for price on the following basis:

- 13.1.3 Note: Evidence to be submitted by Emerging Micro Enterprise (EME) and Qualifying Small `` Enterprise (QSE) sworn affidavit (DTI or CIPC Template, Generic entities SANAS accreditation.
- **13.2** Bidders who qualify as EMEs and QSEs in terms of the B-BBEE Act must submit a Sworn affidavit. Misrepresentation of the information constitutes a criminal offense.
- 13,3 Bidders other than EMEs or QSEs must submit their original and valid B-BBEE status level



verification certificate and BBBEE Scorecard, substantiating their B-BBEE rating and black ownership issued by SANAS.

13.4 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

13.5 Consortium

- 13.5.1 A consortium is an association of two or more individuals, companies, organisations, or governments (or any combination of these entities) with the objective of participating in a common activity or pooling their resources for achieving a common goal.
- 13.5.1. A consortium requires that each participant retains its separate legal status and the consortium's control over each participant is generally limited to activities involving joint endeavors', particularly the division of profits. A consortium is formed by contract, which delignates the rights and obligations of each member.
- 13.5.2. In a consortium, only the lead bidder's credentials both in terms of financial and technical qualifications are considered. Therefore, the interpretation and application to an RFQ/Bid process are such that the lead partner is identified, and the following requirements are required as follows:

a) Lead Partner

- All administrative documents (consortium agreement between the lead partner and the partner)
- Technical requirements (which will show in the proposal and other requirements why the need for the consortium, which for all intent and purpose fulfills the requirements of the bid through the combination of skills)

b) Partner

- Proof of CSD registration.
- Tax Pin.
- BBBEE Sworn-Affidavit.
- SBD 4
- 13.5.3 It should be taken into cognisance that although the lead partner is the qualifying entity, the partner should prove that it can do business with state-owned entities, through CSD registration, proof that the taxes are compliant, its level of BBBEE status in order to align with the BBBEE status level required by the BID, declare interest and answer questions that it is not a disqualified entity with the National



Treasury. The foregoing ensures compliance from an SCM process perspective that the consortium is in order.

13.5.4. Of importance is that in a consortium, each individual team members retain their identity.

13.6 A joint venture

13.6.1. A joint venture is a business entity created by two or more parties, generally characterized by shared ownership, returns and risks, and shared governance.

13.7 Unincorporated joint venture:

- 13.7.1. All SCM documents are filled in by the joint venture in the name of the joint venture, although the submission of administrative documents (partnership agreement between parties) will be completed in the name of the joint venture, and the following will be required from both parties, amongst others.
 - a) SBD 4
 - b) SBD 6
 - c) Tax pin
 - d) CSD registration.
 - e) The JV agreement will direct which bank account of the two entities will be used.
 - f) Consolidated Joint BBBEE Certificate.

13.8 Incorporated joint venture

- 13.8.1 This is aligned to a registered entity or company. A registered entity/ company with a consolidated BBBEE certificate and a bank account in the name of the Joint venture. The required compliance documents must be completed by the entity/ company the name of the joint venture, and the following will be required amongst others
 - a) SBD 4
 - b) SBD 6
 - c) Tax pin
 - d) CSD registration.
 - e) The JV agreement will direct which bank account of the two entities will be used
 - f) Consolidated Joint BBBEE Certificate.
- 13.8.2 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the



value of the contract to any other enterprise that does not qualify for at least the points that such a bidderqualifies for unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.

13.9 A person awarded a contract may not sub-contract more than 25% of the value of the contractto any other enterprise that does not have equal or higher B-BBEE status level than the person concerned unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

14. COMMUNICATION

14.1 Respondents are warned that a response will be disqualified should any attempt be made by a bidder either directly or indirectly to canvass any officer(s) or employees of INSETA in respect of the BID process, between the closing date and the date of the award of the business.

All inquiries relating to this BID should be emailed three days before the closing date.

15. CONDITIONS TO BE OBSERVED WHEN BIDDING

- 15.1 The organization does not bind itself to accept the lowest or any BID, nor shall it be responsible for or pay any expenses or losses which may be incurred by the bidder in the preparation and delivery of his BID submission. The organization also reserves the right to withdraw or cancel the BID at any stage.
- 15.2 No BID shall be deemed to have been accepted unless and until a formal contract/letter of award is prepared and executed.
- 15.3 The competitive shall remain open for acceptance by the Organization for a period of **90 days** from the closing date of the RFQ Enquiry.
- 15.4 **INSETA reserves the right to:**
- 15.5 Not evaluate and award a bid that does not comply strictly with this BID document.
- 15.6 Make a selection solely on the information received in the Bid Document and Enter into negotiations with any one or more of the preferred bidders(s) based on the criteria specified in the terms of reference.
- 15.7 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the BID shall be sought, offered, or permitted.



- 15.8 Cancel this BID or RFQ at any time as prescribed in the PPPFA.
- 15.9 Should bidder(s) be selected for further negotiations; they will be chosen on the basis of the cost-effectiveness and the principle of value for money not necessarily on the basis of thelowest costs.

16 Cost of Bidding

16.1 The bidder shall bear all costs and expenses associated with the preparation and submission of its BID submission and the INSETA shall under no circumstances be responsible or liable forany such costs, regardless of, without limitation, the conduct or outcome of the bidding, evaluation, and selection process.

17. Note to Bidders:

17.1 Due diligence to be conducted by INSETA prior to the award of the contract.
