2. ID or passport number of applicant.
3. Details of current employment (employer, position & years in employment)
4. Province where applicant is based.
5. Choice of qualification – see above table.

### Specializations:


Candidates registering for the RPL programme and for each qualification will have a choice of specializations (choose only 1 specialization) as follows:

### Important Notes:

- Candidates whose expression of interest letters are received by closing date and have been successfully evaluated will be invited by the SDP for further screening.
- Successful candidates registered for the RPL program will be certificated by the Quality Council for Trades & Occupations (QCTO) after successfully passing the compulsory External Integrated Summative Assessment (EISA) examination. EISA is a centralised, formal and supervised examination.
- The implementation of the program is expected to start in September 2023 and end in Feb 2024. This is an INSETA funded program – candidates will **NOT** be expected to pay any fees to the SDP to participate in the RPL program.
- Other details regarding the program will be shared with approved candidates during a pre-commencement orientation. The SDP will facilitate the orientation.
