- 3. The employers must be willing to absorb the graduate on completion of the programme (subject to the graduate is deemed competent and willing to remain in the sector on completion of the programme)
- 4. The employers must be willing to top-up the stipend (co-funding) in order to meet the programme requirements and to retain the graduates till the end of the programme.
- 5. No Employer will be considered for funding outside the funding process.
- 6. INSETA will not fund any graduate that the Employer commences before the approval of this application.
- 7. Previous track record for SETA funded programme will be considered (for those not applying for the first time) during the evaluation process of the application submitted.
