- Successful candidates registered for the RPL program will be certificated by the Quality Council for Trades & Occupations (QCTO) upon passing the compulsory External Integrated Summative Assessment (EISA) examination. EISA is a centralised, formal and supervised examination.
- Program implementation is expected to start in June 2024 and end in March 2025.
- This is an INSETA funded program – candidates will **NOT** be expected to pay any fees to the SDP to participate in the RPL program.
- Other details regarding the program will be shared with approved candidates during a pre-commencement orientation session. The SDP will facilitate the orientation.
