<b>Subject :</b>	Extension of SDP Accreditation and Assessor Moderator Registration

This memo serves to advise Insurance and related financial services stakeholders of arrangements in place to extend the accreditation and registration end dates for eligible Skills Development Providers (SDPs), Assessors and Moderators, per the INSETA issued circular, "*Implications on the Directive on the Implementation and Transitional Agreements for PRE-2009 Qualifications*" dated 19 June 2024.

### The INSETA shall accordingly:

- a) Issue an extension of SDP accreditation, assessors and moderators registration for a period of one year, up to the **30 June 2025**.
- b) The extension of SDP accreditation, assessors and moderators registration is not a blanket extension. Extension letters shall be **issued to**, skills development providers or assessors and moderators who are linked to SDPs or Employers that have registered learners on the INSETA's MIS system, captured before the 30th June 2024.
- c) Extensions shall be issued at the discretion of the INSETA and shall be reviewed on an annual basis subject to, the readiness of occupational qualification delivery.
- d) A decision to extend or lapse the SDP accreditation or assessor moderator registration will be communicated 60 days prior to recorded accreditation or registration end dates.

We are please to advise that the process of SDP accreditation and assessor moderator extension has began, with an envisaged completion date of 12 July 2024.

Stakeholders no longer requiring an extension of SDP accreditation or assessor moderator registration, are advised to inform the INSETA ETQA before the 12 July 2024.
