This communication serves to update the sector regarding the notice number 4920 in Government Gazette No. 50742 issued on the 3rd June 2024, for implementation of occupational qualifications and transitional arrangements at INSETA.

Following the Ministerial Directive related to accreditation and re-accreditation of legacy qualifications, please note the following updates:

- 1. Accreditation extensions have not been blanket-applied, only those SDPs that met the compliance criteria at the time of issuing have been granted extensions.
- 2. These extensions are valid until 30 June 2026, specifically for the delivery of legacy qualifications registered on the NQF.
